1. What Regulates This Privacy Policy

This Privacy Policy (hereinafter referred to as the "Privacy Policy") applies to all information, including personal data, in the understanding of Russian law (Hereinafter referred to as "Personal Information"), which Selebrium Rus LLC may obtain about you in the course of your use of the Celtic-X mobile application, as well as in the course of execution by Selebrium Rus LLC of any agreements and contracts concluded with you complimented by your use of the Celtic-X mobile application.

"Selebrium Rus" LLC may also receive Personal Information from its partners (hereinafter referred to as "Partners"), websites, programs, products or services of which you use in the course of operation of the mobile application Celtic-X. In such cases, the transfer of Personal Information is possible only in cases established by the applicable legislation and is carried out on the basis of special agreements between LLC «Selebrium Rus» and each of the Partners. Please note that the use of any of the Sites and/or Services may be subject to additional terms and conditions that may make changes and/or additions to this Policy.

2. Who processes information

Your Personal Information is collected and used by Selebrium Rus Limited Liability Company, a legal entity established under the laws of the Russian Federation and registered at Glinishevsky Lane 3, Room. 320, Moscow 125009, or its affiliate providing the relevant Service, to ensure your use of the mobile application, Celtic-X. Information about which person provides a Service can be found in the terms and conditions of the corresponding Service.

3. What is the purpose of this Policy

Protection of your Personal information and your privacy is extremely important for LLC «Selebrium Rus». Therefore, when You use the mobile application of Celtic-X LLC «Selebrium Rus» protects and processes Your Personal Information in strict compliance with Russian legislation.

Following our responsibility to protect your Personal Information, in this Policy we would like to inform you most transparently about the following points:

- Why and how LLC «Selebrium Rus» uses ("processes") your Personal Information when you use the mobile application Celtic-X;
- What is the role and responsibilities of LLC «Selebrium Rus» as a legal entity deciding why and how to process your Personal Information;
- What are your rights as part of the processing of Personal Information.

4. What Personal Information about you is collected by LLC «Selebrium Rus»

We collect e-mail addresses of those who register through the Celtic-X mobile app; information voluntarily provided by the users: last name, first name, age, city of residence, marital status, field of work, number of children, income level.

The information we collect is used to determine User's participation in a particular target audience for marketing research purposes and the quality of our services and is not transferred to other organizations for commercial purposes, except where we have your permission to provide such information, as well as cases of provision of information at the request of State structures entitled to do so within the framework of the legislation of the Russian Federation.

In addition to the above mentioned, LLC «Selebrium Rus» may collect the following categories of Personal Information about You during Your use of the mobile application Celtic-X:

- Personal information provided by you during registration (account creation);
- Electronic data (IP address, hardware and software information);
- Date and time of access to the mobile application, Celerra-X;
- Geolocation information;
- Other information about you required for processing in accordance with the terms and conditions governing the use of the mobile application of Celtic-X;
- Information about you, which we receive from our Partners in accordance with the terms of agreements, concluded between you and the corresponding Partner, agreements concluded between LLC «Selebrium Rus» and the Partner.

LLC «Selebrium Rus» does not collect purposefully sensitive Personal information (such as racial origin, political views, health information and biometric data). Selebrium Rus LLC does not collect data for the purpose of drawing up a "portrait" of the user to the extent that this may significantly affect your rights and freedoms.

5. How Selebrium Rus LLC protects your Personal Information

In most cases, Personal Information is processed automatically without access to it by one of the employees of LLC «Selebrium Rus». In case such access is necessary, it can be granted only to those employees of LLC «Selebrium Rus» who need it to perform their tasks. In order to protect and ensure security the confidentiality of data, all employees must observe internal rules and procedures regarding the processing of Personal Information. They must also follow all technical and organizational security measures in place to protect your Personal Information.

LLC «Selebrium Rus» has also implemented sufficient technical and organizational measures to protect Personal Information from unauthorized, accidental or illegal destruction, loss, modification, unfair use, disclosure or access, as well as other illegal forms of processing. These security measures have been implemented taking into account the current state of the art, the cost of their implementation, risks related to the processing and nature of Personal Information.

6. Data Storage

LLC «Selebrium Rus» uses third-party vendors and hosting partners to provide the necessary hardware, software, networks, storage, and related technologies required to launch a mobile application, the Celtic-X. Although LLC «Selebrium Rus» owns the code, databases, and all rights to the Celtic-X app, you retain all rights to your data.

Our servers for storing your personal data are located in Russia and use the latest hardware and software for personal data protection.

7. Who else has access to your Personal Information and to whom it can be transferred

LLC «Selebrium Rus» may transfer your Personal Information to its employees (within the limits specified in the relevant section of this Policy).

If you use a mobile application, you may send your Personal Information to LLC NCO «Yandex.Money» for processing on the terms and for the purposes specified in the Agreement on Use of the Service of «Yandex.Money» (<https://money.yandex.ru/doc.xml?id=522764>) and the Privacy Policy of LLC NCO «Yandex.Money» (<https://money.yandex.ru/doc.xml?id=525698>).

LLC «Selebrium Rus» can also transfer Personal Information to third parties. Such third parties may include:

- Partners, such as owners of web sites and applications, advertising networks and other partners providing services

to LLC «Selebrium Rus» related to placement and display of advertising on web sites, programs, products or services owned or controlled by such partners;

- Third parties with respect to whom the assignment of rights or obligations has been made or novation under the relevant agreement;
- Any national or international regulatory body, law enforcement agency, other official or public authorities or court in respect of which LLC «Selebrium Rus» is obliged to provide information in accordance with applicable law upon request;
- Third parties, if you have consented to the transfer of your Personal Information or the transfer of Personal Information is required to provide you with the relevant Service or to perform a certain agreement or agreement concluded with you;

8. Your Rights and Responsibilities

What rights do you have:

If provided by applicable law, you are entitled to access your Personal Information processed by LLC «Selebrium Rus» in accordance with this Policy.

If you believe that any information that LLC «Selebrium Rus» stores about you is incorrect or incomplete, you can log in to your account and correct your Personal Information by yourself.

If provided by applicable law, you may:

- Require removal of your Personal Information;
- Require restrictions on processing your Personal Information;
- Argue the processing of your Personal Information if provided by applicable law.

In cases provided by Russian law, you may also have other rights not mentioned above.
